- ◆ **Call to Order:** Tom Sommers called the Remington Unified School District 206 Board of Education Meeting to order at 7:30 p.m. on June 12, 2017 at the Remington District Office, 110 South Main, Whitewater, Kansas.
- ◆ **Members Present:** Tom Sommers; President, Bret Mosiman; Vice President, members, Jayne Carey, Doug Claassen, Kendall Claassen, and Brad Crisp
- ◆ **Member Absent:** Penny McNeill
- ◆ **Others Present:** James Regier and Martina Bumm
- ◆ **Opportunity to Add Agenda Items:** No additions
- ◆ **Approval of Agenda:** Motion to approve agenda. (Mosiman), seconded (Crisp), carried 6-0.
- ◆ **Consent Agenda:** Motion to approve all items on the consent agenda. (D. Claassen), seconded (K. Claassen), carried 6-0.
- ◆ **Patrons Open Forum:** No patrons requested to address the board.
- ◆ **Superintendent Report:**
 - Budget Closeout – Mr. Regier asked that the board allow the budget closeout (for 2016-2017 fiscal year) to occur at the July board meeting. Board was in agreement to allow this to happen.
 - Legislative Update/Funding Rates – Mr Regier gave an update regarding the school finance bill that was recently passed by the legislature and sent to the governor.
 - Worker's Compensation Premium – Next year's worker's compensation premium will be \$18,256 which is down \$14,469 from the previous year.
 - Graduation Date for 2017-2018 – School board was in agreement to move graduation to Saturday May 13, 2018 @ 11:00am to avoid Mother's Day and graduate at a time of day which is cooler.
- ◆ **Executive Session:** Motion to go into Executive Session at 7:58 p.m. to discuss personnel issues in order to protect the privacy interests of the individuals to be discussed and negotiations to protect the public interest in negotiating a fair and equitable contract and that we return to open session in this room at 8:12 p.m. (Crisp), seconded (D. Claassen), carried 6-0. Board returned to open session at 8:12 p.m.
- ◆ **Action from Executive Session:** Motion to hire Casey Gobel as RHS Asst. Football Coach, Lisa Hochstetler as RHS Volleyball Head Coach, Chris Lawler as RMS Asst. Football Coach, John Bumm as RHS Asst. Boys Basketball Coach, and Haley Freking as RHS/RMS Asst. Cross Country Coach for the 2017-2018 school year. (K. Claassen), seconded (B. Crisp), carried 6-0.
